



Back to the Game 2020-2021 season
Covid-19 Regulations
Dorval Arena and Westwood Sports Centre

The City will be opening the Dorval Arena and Westwood Sports Centre for City programs, associations and commercial rentals.
In view of the current pandemic, it is the responsibility of the users/renters to respect and apply the following regulations to all member of their group.

1. It is important to know that the City adheres to the recommendations of Quebec's Public Health as well as Quebec's sports federations with regards to the number of participants allowed on the ice and the number of participants and coaches on the bench.
2. The City requires each user/renter to designate a person who will be responsible for on site enforcement of the rules indicated below.

In addition, the City requests that the designated person complete for each session the Covid-19 questionnaire prepared by the City, and received along with the ice contract. Each person must answer the four questions by placing a check mark in the appropriate box and indicate their name and phone number. Before having access to the ice, the completed Covid19 questionnaire must be given by the designated person to the City employee who is on duty.

3. All persons entering either building must wear a facemask and wash their hands otherwise, their access will be denied.

- 4.** An employee of the City will ensure compliance with the following regulations hand washing; wearing a facemask, receiving the completed Covid-19 questionnaire; participants are in the right places at the right times; respect of the allocated time; social distancing (2 meters). Anyone who violates one of these regulations can lose their access to the ice.
- 5.** Participants must arrive wearing all of their skating attire with the exception of their helmet, gloves and skates.
- 6.** Locker rooms are not accessible.
- 7.** During the activity, the City will establish an area near the players' bench for bags containing each skater's personal items.
- 8.** All skaters must go to the designated area to remove their skates, helmet, gloves, and put on their boots, coat and facemask. They have a maximum of 15 minutes to leave the arena by the designated exit door.
- 9.** The City allows access to only one spectator per family and this spectator must sit in the identified area.
- 10.** Gatherings in the lobby, corridor and stands are prohibited.
- 11.** All persons present in the buildings must respect the directional signage as indicated on the floor.
- 12.** Water fountains can only be used to fill personal water bottles..
- 13.** The City recommends that anyone with a chronic disease, immunosuppressed system or 70 years of age and older stay at home.
- 14.** The canteen will be closed.
- 15.** Food is prohibited on site.
- 16.** Anyone showing symptoms of fever, sore throat, cough, diarrhea, difficulty breathing, headache, loss of smell and taste should not enter any City facilities.
- 17.** If one of your participants is diagnosed positive for the Covid-19 virus, the group designated person must contact anyone who have been in contact with this person during the activity. The City must be contacted and informed of the situation.
